## **DIRECT INVESTMENT**

(January - September 2009)<sup>1</sup>


According to preliminary data, the **Foreign direct investment in Bulgaria** for January – September 2009 amounted to EUR 2,112.1 million (6.3% of GDP) compared to EUR 5,075.9 million (14.9% of GDP) attracted in January – September 2008.

The attracted Equity Capital (acquisition/disposal of shares and equities in cash and contributions in kind by non-residents in/from the capital and reserves of Bulgarian enterprises and receipts/payments from/for real estate deals in the country) for January – September 2009 amounted to EUR 1,665.3 million, which was 78.8% of the foreign direct investment. It decreased by EUR 917 million compared to that attracted in the same period of 2008 (EUR 2,582.3 million, 50.9% of total foreign direct investment). The receipts from real estate investments of non-residents amounted to EUR 433.4 million compared to EUR 1,081.4 million for January – September 2008.




The other capital, net (the change in the net liabilities of the direct investment enterprise to the direct investor on financial loans, suppliers' credits and debt securities) was positive, amounting to EUR 193.1 million in January – September 2009, compared to a net other capital amounting to EUR 2,061.4 million in the same period of 2008.

According to preliminary data, the *Reinvested Earnings*<sup>2</sup> (the share of non-residents in the undistributed earnings/ loss of the enterprise) in January – September 2009 are estimated at EUR 253.8 million compared to EUR 432.2 million in the same period of 2008.

By country, the largest investments in Bulgaria for the reporting period were those of the Netherlands (34.6% of the total foreign direct investment), Romania (11.9%) and Austria (9.2%).



By branch, the largest investments for January – September 2009 were in *Financial Intermediation* (EUR 841.9 million), *Real Estate* (EUR 390.6 million) and *Transport, Storage and Communication* (EUR 226.7 million).



According to preliminary data in January – September 2009 **Direct investment abroad** increased by EUR 85.6 million compared to an increase of EUR 457.4 million in January – September 2008. The equity capital invested abroad in January – September 2009 amounted to EUR 65.9 million, compared to EUR 475.9 million in January – September 2008.

Preliminary data for 2008 and 2009. The data for August 2009 are revised. When comparing the data yoy it should be taken into account that the initial data on the January – September 2008 FDI, published in a BNB press release as of November 14, 2008 (www.bnb.bg, section Statistics/Balance of Payments/Press Releases), was subsequently revised. The 2008 and 2009 data are subject to revisions with the quarterly reports to the BNB from foreign direct investment enterprises and with the annual NSI data, and for 2009 also with the quarterly NSI data. GDP for 2008 (preliminary NSI data) - EUR 34,117.5 million and forecast GDP (preliminary BNB estimate) for 2009 - EUR 33,480 million.
