## DIRECT INVESTMENT (January – September 2016)<sup>1</sup>

According to preliminary data, *foreign direct investment in Bulgaria* presented according to the *directional principle* amounted to EUR 1,271.2 million (2.8% of GDP<sup>2</sup>) in January – September 2016, dropping by EUR 339.2 million (21.1%) from January – September 2015 (EUR 1,610.4 million, 3.6% of GDP)<sup>3</sup>. In September 2016 *foreign direct investment in Bulgaria* grew by EUR 2.6 million, compared with an increase of EUR 128.4 million in September 2015.



A positive sign denotes an increase in assets and liabilities; a negative sign denotes a decrease in assets and liabilities.

Equity (acquisition/disposal of shares and equities in cash and contributions in kind by non-residents in/from the capital and reserves of Bulgarian enterprises, and receipts/payments from/for real estate deals in the country) amounted to EUR 298.2 million in January – September 2016. It fell by EUR 642.3 million in comparison with that attracted in January – September 2015 (EUR 940.5 million).



Real estate investments of non-residents totalled EUR 53.6 million, compared with EUR 46.8 million attracted in January – September 2015. The largest inflow of real estate investment was from Switzerland – EUR 22.7 million (42.4% of the total amount for January – September 2016), Russia (EUR 6.6 million, 12.3% of the total amount for the period), and Norway (EUR 6.1 million, 11.4% of the total amount for the period).

Reinvestment of earnings (the share of non-residents in the undistributed earnings/ loss of the enterprise based on preliminary profit and loss data) was estimated at EUR 594.2 million for January – September 2015, compared with EUR 610.8 million in the same period of 2015.

The net *debt instruments* (the change in the net liabilities between affiliated enterprises on financial loans, suppliers' credits and debt securities) were positive amounting EUR 378.8 million in January – September 2016, compared with a positive balance of EUR 59.1 million in January – September 2015<sup>4</sup>.

The largest net direct investment inflow in Bulgaria for January – September 2016 was from the Netherlands (EUR 233.2 million, 18.3% of the total amount for the period), Germany (EUR 187.8 million, 14.8%), and the United Kingdom (EUR 149.1 million, 11.7%).



According to preliminary data, *direct investment abroad* totalled EUR 107.2 million in January – September 2016, compared with an increase of EUR 44.7 million in January – September 2015. In September 2016 it grew by EUR 8.7 million, compared with an increase of EUR 23.4 million in September 2015.
